



Teri V Travel's Price Promise and/or a \$75 Credit/Rebate For That Next Vacation *

Understanding you deserve exceptional personalized attention to detail.....

How does Teri V Travel's Price Promise Program Work?

If you find a vacation package from another travel provider (excluding an auction site, Expedia, Orbitz, Kayak, Travelocity or Lowest Fare) at a lower price, Teri V Travel will beat the same package **if possible** by offering a \$10/per Adult Deduction and/or \$5/Per Child Deduction off the vacation. This applicable Competitor's quote must be within 2 days of Teri V Travel's initial quote.

If Teri V Travel **Can't** match the applicable competitor's quote and you still choose to travel with Teri V Travel – Teri V Travel will go one further and offer you a \$75 Credit/Rebate off your next scheduled vacation with Teri V Travel upon completion of your first initial vacation.. This certificate is to be issued upon your return from your first trip that Teri V Travel could not match and to be completed within 18 months of the date of the first trip that Teri V Travel could not match.

Who will Teri V Travel Price Promise?

Applicable North American Competitors would include quotes from IATA/ARC registered businesses such as :

- Other travel agents within the United States – North America
- Other Tour operators within the United States – North America
- Other Airlines within the United States – North America

*Travel must originate from within North America Only. Again no auction sites, or Expedia, Orbitz, Travelocity, Lowest Fare or Kayak sites.

What do I need as a client to get the Price Promise?

All you need are the details of the quote, and the competitor's name. A written quote with the applicable competitor's logo is mandatory for this promise to apply and the applicable competitor's quote needs to be presented to Teri V Travel within two days of Teri V Travel's initial quote. That is to be Price Promised/ and/ \$75 Credit/Rebated.

Some Other Important Details To Bear In Mind

The Price Promise does not include rates offered on membership programs such as Costco/Sams Club etc.. Nor does it apply to any corporate discounts or rates, group charter or rewards programs or military/government rates/discounts. Any applicable competitor who is offering promotional packages, deals or bundles that may include **additional** amenities such as parking, meals or entertainment are not eligible as well. This also applies to special promo codes that Teri V Travel may not have access to as well. Exact same flights, exact same rooms, exact itinerary thru and thru for the exact same dates and exact same restrictions only apply. Apples to Apples so to speak...

The Price Promise is only available prior to purchasing a package from Teri V Travel and should be consistent in date with the other applicable competitor's date. Furthermore – the other applicable competitor's quote must be available to be booked at the time of the Price Promise – Not in the past or the future. The Price Promise applies to car rentals and airfare that are **ONLY** purchased as a package with the hotel – These components **will not** be price promised independently. And the Price Promise only applies to the base cost of the package and not the taxes/fees that other tour providers, travel agents, cruise lines and airlines choose to apply.

What if There Are Changes to the Price Promise Program offered by Teri V Travel?

Teri V Travel has the right to modify or discontinue the Price Promise Program and the \$75 Credit/rebate Program at any time without prior notice. Any changes to this policy – all clients will be notified via email address provided at the time of consulting for travel services with Teri V Travel and Teri V Travel will display via our website address – www.terivtravel.com. No change to the Price promise Program will affect any \$75 Credit/Rebate that has already been issued to you for future travel.

\$ 75 Credit/Rebate terms and conditions.....

This \$75 Credit/Rebate has been supplied to a client as a gesture gift of good faith and it is part of the Price Promise Program. It has been issued as part of the confirmation of Teri V Travel's inability to match an initial applicable competitor's package quote and the client still chooses to book and complete that first initial package with Teri V Travel. The \$75 Credit/Rebate gift is only available prior to purchasing an air/ land package or cruise from Teri V Travel - No other competitor. There is a limit of one \$75 Credit/Rebate per entire booking to cover all ticketed travelers and two \$75 Credit/Rebates per client per year. Each \$75 Credit/Rebate is valid for 18 months from date of issuance on future purchases of air/land packages contracted to Teri V Travel only.

Redeeming the \$75 Credit/Rebate....

The client must have a land value (excluding air) on their new package not less than \$1500. There is a limit of one \$75 credit/rebate per new purchase. The new purchase is a completely separate booking from the initial Price Promise quote – New dates, new itinerary, new hotel etc ... Extensions to the valid thru date on the \$75 Credit/Rebate will not be permitted and the \$75 Credit/Rebate will not be replaced or reissued for any reason. \$75 Credit/Rebates are not redeemable for cash, are not transferable or assignable and may not be purchased or auctioned and any attempt to do so will result in voiding of the \$75 Credit/Rebate – The \$75 Credit/Rebate has no cash value as well.
